Expansion Consultation

To students, parents/carers, staff, governors, and stakeholders

The Governing Board of Hailsham Community College is proposing to expand the College from 1620 to 1920 (420 of these pupils are primary age and taught at the Park Road site), plus 240 post 16 pupils. This will increase the planned admission number (PAN) at the secondary phase from 240 spaces to 300 spaces per year group.

Why do we need to expand Hailsham Community College?

East Sussex County Council (ESCC) would like to expand Hailsham Community College to provide more places for local children and young people. Demand for school places in the area the college serves has increased in recent years, and is likely to continue, as a result of new housing developments. ESCC has a statutory duty to ensure there are enough school places and is therefore proposing to expand Hailsham Community College to create additional capacity. If the proposal goes ahead additional accommodation would be provided to enable the college to expand.

Hailsham Community College has become more popular in recent years and Year 7 intake has been oversubscribed. The current PAN of 240 provides limited scope to meet parental preference in the future, and students that live in the town are finding that they need to travel further afield for secondary education.

Are there site plans to show how the college would be expanded?

A planning application has been submitted detailing the construction of an additional 3 storey block to replace a current single storey facility.

Expansion plans are subject to planning permission and are due to be presented to the planning committee in November. A consultation event took place at the college in July and all stakeholders, including local residents, were given the opportunity to view the plans, ask questions and make comments.

This enabled the design team to take into consideration everyone's views before the planning application was submitted.

How would the college deal with any possible increase in traffic and congestion?

A traffic and parking assessment has been undertaken and shared with staff, parents/carers and the local community at the pre-planning consultation event mentioned above. The college's travel plan has been updated and will be utilised by the college to encourage families to find alternative ways of travelling to school in order to reduce the number of car journeys in conjunction with additional access to the site.

This consultation deals specifically with the principle of expanding the college to provide more places for local children and young people. This is separate to the pre-planning consultation with the local residents and other stakeholders, around the development of the proposed building works as part of



the usual planning application procedures. Comments made at that stage will form part of the decision making process for the planning committee.

Would the college need to close during building work?

No. The building works would be planned carefully, and contractors would work with the college to ensure that works are scheduled to keep disruption to a minimum. The building site would be a secure area to ensure the health and safety of the children, young people, staff, parents/carers, and visitors to the college.

How many children would be at the college once it is expanded?

It is intended that Hailsham Community College would grow gradually, with 60 additional Year 7 places offered each year until it reaches its new capacity.

The following table illustrates how the number of places at the school might grow:

What happens next?

Following this consultation, a report setting out the responses received on the proposal to expand Hailsham Community College will be submitted to the Governing Board of the College. The Governors will then consider these responses in respect to the proposed expansion.

The College will then need to apply for a significant change to Academy to the Secretary of State for Education for permission for the proposed expansion

The proposed expansion would be dependent upon planning permission being granted for the building works to the college premises as outlined above.
